

In the beginning the cell walls (cell membranes) are damaged and hard. Nutrients cannot go in, waste cannot be eliminated.


Very powerful nutrients must be taken to restore the openings of the cell membrane allowing nutrients inside. Then repairs and cleansing inside the cell can begin.

STEP #2 **Cleansing & Balancing The Intestinal Tract**


